WHEREAS: We, the Listuguj Mi'gmaq Government (LMG), strongly believe in our culture, language, tradition, our aboriginal and treaty rights, and most of all, our People;

WHEREAS: We stand by our Vision "Getlamite'teg enmina'qeg ugjit wejgwapegsultijig. Ta'n telteapu'mimajulti'gw gennmu'g, ango'tmu''g aq nujo'tmu'g 'ms't gm'tginaq ta'n Teli'sulti'gw, telangita'sulti'gw aq telinnulti'gw — Our vision for generations to come. Living our rights and responsibilities as Listugujewaq by speaking, thinking and being Mi'gmaq.";

WHEREAS: In 2018, the Listugujewei Land Use Plan was created by the community of Listuguj, and they identified the need for a space dedicated to language, culture, and ceremony;

WHEREAS: In 2020, land was allocated for healing, language, and culture by the Chief and Council;

WHEREAS: In 2021, Mi'gmaw Language & Culture Revitalization Coordinator/ Proposal Writer identified and secured \$1,150,000 (One Million, and One Hundred and Fifty Thousand) from Crown-Indigenous Relations and Northern Affairs Canada for the Cultural Spaces in Indigenous Communities Program (CSICP);

WHEREAS: LMG must provide a 10% contribution to the project, a total amount of \$150,000 (One Hundred and Fifty Thousand) from OSR must go towards the construction of the Listuguj Mi'gmaw Language & Cultural Center;
