**WHEREAS:** the Mi'gmaq have Aboriginal Rights and Title in and over Gespe'gewa'gi and have a special relationship; traditionally, spiritually and culturally, with its lands, islands, air, waters and natural resources.

**WHEREAS:** the Mi'gmaq of Gespe'gewa'gi entered into a nation-to-nation Treaty relationship with the Crown based on peace and friendship and reciprocity which reaffirms our rights including our right to self-government and the right of trade;

**WHEREAS:** the Chiefs of the Mi'gmawei Mawiomi have signed the Gespe'gewa'gi Saqamawut; a joint declaration outlining their interests and consultation and accommodation requirements;

**WHEREAS:** in light of the resolution of 2009, the Consultation Unit of the MMS has been established sine July 2009, staffed and began to receive consultation requests for the three communities to facilitate the consultation process;

**WHEREAS:** there are outstanding issues and ongoing files in the area of consultation and accommodation measures between Listuguj, the MMS and the provincial government of Quebec;

**WHEREAS:** the Consultation & Accommodation Unit will present regularly progress reports to the LMG Council on the status of active files and the process of Consultation and Accommodation

## THEREFORE BE IT RESOLVED:

**THAT:** the Listuguj Mi'gmaq Government and Mi'gmaqwei Mawiomi Secretariate will establish a transition plan for the Consultation and Accommodations files

## **THAT:**

1. The Listuguj Mi'gmaq Government hereby provides direction to the Mi'gmawei Mawiomi Secretariat to facilitate the consultation process with their member communities and its leadership and considering it is part of Gespe'gewa'gi and the larger Mi'gmaq nation; consultations will be undertaken under the context of Nation perspective
2. The Mi'gmawei Mawiomi Secretariat will continue to manage the consultation and accommodation unit with the funds provided by the Secretariat aux Affaires Autochtones under the contribution agreement and that a resolution from the council as required
3. The Listuguj Mi'gmaq Government hereby authorize the Executive Director of the Mi'gmawei Mawiomi Secretariat, to sign all contribution agreements and documents with the Secretariat aux Affaires Autochtones necessary for the administrative matters of the unit continue
4. That the Mi'gmawei Mawiomi will administer the contribution agreement under its administrative and financial policies and will report to the Listuguj Mi'gmaq Government through an Annual General Assembly on the use of funds and to what process the files took bi-annually
5. The Listuguj Mi'gmaq Government will be provided all consultation reports to ratify through the process agreed upon between the MMS and LMG.

**THAT:** This Order in Council rescinds Order in Council #2506 dated October 22, 2019.
