WHEREAS	on or around October 4, 2015, Ms. Lorna Sook wrote to Chief and Council of LMG and indicated that the Minutes were inaccurate and/or asked to have the Original Text removed;				
WHEREAS	on or around December 4, 2015, Ms. Sook, through her legal counsel, asked Chief and Council to amend the Minutes and/or have the Original Text removed;				
WHEREAS	LMG, through its legal counsel, responded to Ms. Sook and denied the allegations she had made in regards to the Minutes and the Original Text;				
WHEREAS	on or around April 14, 2016, Ms. Sook filed a complaint with the Office of the Privacy Commissioner of Canada (the "OPCC") alleging, among other things, that LMG had infringed the Personal Information Protection and Electronics Act and/or the Privacy Act in having posted the Minutes on its website (the "Complaint");
