WHEREAS: As of July 1st, 2023, FNRAEC Listuguj, Elawsimgewei Gina'muo'guom administers funds received from the First Nations Adult Education School Council (FNAESC).

WHEREAS: The First Nations Adult Education School Council has given signing authority for financial transactions related to Adult Education to the Co-Managers of Elawsimgewei Gina'muo'guom for the processing of their operational budget, as per the availability of approved funds.

WHEREAS: The FNAESC is funded by the Ministère de l'Education et l'Enseignement Supérieur (MEES) and Indigenous Service Canada (ISC), where historically, ISC contributes 1/3rd of the MEES' contribution.

WHEREAS: In fiscal year 22-23, ISC contribution amount is 34 % of the MEES contribution, as its final direct contribution to the FNAESC.

WHEREAS: Beginning fiscal year 22-23, ISC contribution amounts will be included in community contribution agreements as per the Nominal Roll generated by the adult education students at Elawsimgewei Gina'muo'guom and the vocational students sponsored by the LMDCenter, both to be included in the line item "Adult Education".

WHEREAS: Contribution amounts vary from year to year, based on the previous year's Nominal Roll and any update(s) in the funding formula.

WHEREAS: Funds will be divided between FNRAEC Listuguj, Elawsimgewei Gina'muo'guom and the LMDC according to the Nominal Role submitted from each organization using the funding formula from ISC.

WHEREAS: The Listuguj Mi'gmaq Government recognizes that the FNRAEC Listuguj, Elawsimgewei Gina'muo'guom is the administrator of it's operational funds.

BE IT THEREFORE RESOLVED:

THAT: the Listuguj Mi'gmaq Government approves the direct transfer of Adult Education Nominal Roll funds from ISC to the FNEASC equivalent to the historical ratio of the MEES funding and proportionate to the contributions of the other Regional Adult Education Centers.

BE IT FURTHER RESOLVED:

THAT: the Listuguj Mi'gmaq Government approves the direct transfer of funds from ISC to the FNRAEC Listuguj, Elawsimgewei Gina'muo'guom for the balance of adult education, short term training and vocational training funds generated by the Nominal Roll submitted by Elawsimgewei Gina'muo'guom.

BE IT FURTHER RESOLVED:

THAT: the FNRAEC Listuguj, Elawsimgewei Gina'muo'guom will submit to the Listuguj Mi'gmaq Government Finance department quarterly statements of revenue and expenditures and yearly audited financial statements.
