WHEREAS: The Listuguj Mi'gmaq Government (LMG) has the responsibility to ensure the safety, well-being and peaceful co-existence of its members.

WHEREAS: The LMG is also responsible for community improvement, communication, social advancement, economic development, and good governance.

WHEREAS: The LMG adopted the Listuguj MI'gmaq Community Plan in March 2018 which validated many action areas including, a "Healthy Community and Public Safety".

WHEREAS: Listuguj seeks to resolve ongoing challenges with the following issues:

1. Addresses: Civic, Public, Recreation, Work, Construction, Social

2. Numbering: New series of numbers is required

Streets: Names required, avoid duplication, signs required
 Mapping: Production of maps to share with 911, Emergency, etc.

5. Postal Boxes: Canada Post - Mandatory generic compliance

WHEREAS: In summary, this means that every household in Listuguj will be receiving a new number for their physical address and a new postal box number at the Listuguj Post Office.

WHEREAS: The Listuguj Economic Development Unit (LEDU) is granted the responsibility of bringing forth recommendations for change to the LMG.

WHEREAS: The LEDU has already gained the support of the LMG to hire a Comprehensive Community Planning Coordinator and a Listuguj Properties Coordinator

WHEREAS: The LEDU shall form a steering committee composed of Economic Development Manager, LEDU Admin. Staff, Comprehensive Community Planning Coordinator, Listuguj Properties Coordinator and Listuguj Post Office Manager.

WHEREAS: The Steering Committee will meet weekly to guide, assist, and advance the project(s) towards potential recommendations which will be contained in a final report.
