WHEREAS: The Listuguj Mi'gmaq Government wishes to construct a Healing Lodge and Language/Cultural Center – Turtle Lodge, to provide a safe space for all community members who seek traditional healing; support Mi'gmaw language, cultural and ceremonial initiatives within the community, facilitate crime prevention and reduction of poverty and addictions.

WHEREAS: The Listuguj Mi'gmaq Government successfully obtained \$2,150,000, with a contribution of Own Source Revenue for a total of \$150,000

WHEREAS: Listuguj Mi'gmaq Government called for proposal for on April 28, 2023

WHEREAS: Listuguj Mi'gmaq Government received 3 bids:
LFG Construction – 3,232,950
Kamco Construction – 3,877,000
Edge Line - \$4,474,000

WHEREAS: Clad INC. the project consultant firm was awarded the design contract and has evaluated the tender form submitted

WHEREAS: The consultant and the Directorate of Capital & Infrastructure recommended to phase the project in order to maintain the fund. They recommended three options to move ahead with the project as follows:

- Option 1: Proceed with the full scope of work for a total estimated cost of \$3,931,302 which will require additional contribution of \$1,163,302.
- Option 2: Includes the building structure, including electrical wire, partitions, but no interior doors and finished concrete slab which will require additional contribution of \$883,887
- Option 3: Includes the building envelop, HVAC units, but no partition, no wiring, no ducts which will require addition contribution of \$207,837.
