WHEREAS: The Listuguj Mi'gmaq Government through Order-in-Council #1934 is in support of the Regional Adult Education Center within it's territory.

WHEREAS: The First Nations Regional Adult Education Center Listuguj, Elawsimgewei Gina'muo'guom operates under the direction of the First Nations Adult Education School Council.

WHEREAS: The First Nations Adult Education School Council will be giving signing authority for financial transactions related to Adult Education operational funds on July 31st, 2023, to the Co-Managers of FNRAEC Listuguj, Elawsimgewei Gina'muo'guom for the processing of their budget, as per the availability of approved funds by the First Nations Adult Education School Council.

WHEREAS: The Listuguj Mi'gmaq Government recognizes that the FNRAEC Listuguj, Elawsimgewei Gina'muo'guom is the administrator of operations funds.

WHEREAS: The transfer of Listuguj Adult Education employees from the LMDCentre to the First Nations Adult Education School Council on July 31st, 2023.

WHEREAS: The transfer of The First Nations Regional Adult Education Center Listuguj, Elawsimgewei Gina'muo'guom's operational funds directly to FNRAEC Listuguj Elawsimgewei Gina'muo'guom.

WHEREAS: The First Nations Regional Adult Education Center Listuguj, Elawsimgewei Gina'muo'guom will continue to be accountable and transparent to it's people and the Listuguj Mi'gmaq Government.

WHEREAS: The LMG supports the creation of a local governance committee which should include the co-manager Bella Moffat and Myrna Sook, the Council Liaison appointed as Trustee appointed by the appointer (Chief and Council), and a member of Council as proxy.


