WHEREAS: LMG has completed the design phase of the project and issued a public tender for construction services.

THEREFORE BE IT RESOLVED THAT:

1. Chief and Council hereby ask the SRPNI for the use of the Indigenous Initiatives Fund, Community Infrastructures envelop reserved for the community, in the amount of [REDACTED] for the construction of the new government building project.
2. Chief and Council hereby authorize the allocation of up to [REDACTED] from the Capital and Infrastructure Reserve Fund to cover the remaining project costs.
3. Chief and Council hereby approve the award of the construction contract to the lowest compliant bidder, LFG Construction, in the amount of [REDACTED]
4. Chief and Council commit to replenishing the Capital and Infrastructure Reserve Fund in an amount equivalent to the funds withdrawn from this project, as financial capacity allows.
5. Chief and Council Authorize the Chief Executive Officer to execute the agreement and take all the necessary steps to execute the project
