

# Listuguj Mi'gmaq Government Order-In-Council

**WHEREAS** the Listuguj Mi'gmaq First Nation is a Mi'gmaq community indigenous to Gespe'gewa'gi with a sacred, inherent responsibility for the stewardship of the land, waters, and living things of Gespe'gewa'gi;

**WHEREAS** Listuguj Mi'gmaq First Nation holds existing Aboriginal title, Aboriginal rights, and treaty rights with respect to our lands and resources, and these rights have never been surrendered or extinguished;

**WHEREAS** Mi'gmaq Aboriginal title, Aboriginal rights, and treaty rights are held communally and local Mi'gmaq communities have the authority and autonomy to regulate how they are asserted and exercised;

**WHEREAS** Listuguj exercises its autonomy by, among other things, negotiating bilaterally with the other governments, including the Government of New Brunswick, regarding matters of community concern;

**WHEREAS** the Listuguj Mi'gmaq Government and the Government of New Brunswick have negotiated the Framework Agreement between the Government of New Brunswick and the Listuguj Mi'gmaq Government to enable continued bilateral negotiations on a range of issues of mutual concern;

**NOW THEREFORE THE LISTUGUJ MI'GMAQ GOVERNMENT MAKES THE FOLLOWING ORDER-IN-COUNCIL:**

1. The Framework Agreement between the Government of New Brunswick and the Listuguj Mi'gmaq Government is approved, subject to technical changes required prior to signature;
2. The Chief of the Listuguj Mi'gmaq Government is directed to sign the Framework Agreement between the Government of New Brunswick and the Listuguj Mi'gmaq Government; and
3. The Listuguj Mi'gmaq Government mandates the Executive Office with completing all tasks related to assembling a negotiation team and implementing the Framework Agreement between the Government of New Brunswick and the Listuguj Mi'gmaq Government.
