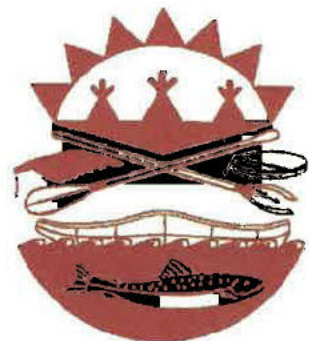

WHEREAS: the Municipality of Pointe-à-la-Croix owns lot [REDACTED] located in the Quebec land registry;

WHEREAS: the Listuguj Mi'gmaq Government owns the following lots, located in the Quebec land registry:



WHEREAS: it is in the interest of the Listuguj Mi'gmaq Government to proceed with a land exchange with the Municipality of Pointe-à-la-Croix involving the transfer of lot [REDACTED] by the Municipality of Pointe-à-la-Croix and the transfer of lots [REDACTED] by the Listuguj Mi'gmaq Government;

WHEREAS: this lot exchange is part of a collaborative approach and meets the land-use planning and public interest needs of the parties;

WHEREAS: the Chief and Council of the Listuguj Mi'gmaq Government wish to authorize the land exchange and all related documentation necessary to give effect to the transaction;

NOW THEREFORE BE IT RESOLVED:

THAT; the Chief and Council of the Listuguj Mi'gmaq Government hereby authorize the land exchange between the Listuguj Mi'gmaq Government and the Municipality of Pointe-à-la-Croix under the following terms:

1. The Municipality of Pointe-à-la-Croix shall transfer lot [REDACTED] excluding lot [REDACTED] to the Listuguj Mi'gmaq Government.
2. The Listuguj Mi'gmaq Government shall transfer lots [REDACTED] to the Municipality of Pointe-à-la-Croix.
3. The Chief and Council authorize the Chief and Chief Executive Officer to review and confirm all matters related to the proposed transfer, including drainage and any other relevant technical, legal, or land-use considerations, and, upon confirmation that such matters are satisfactory, to sign the land exchange agreement, the deed of transfer, and any other documents necessary to give full effect to this Order-in-Council.
4. The Chief and Council approve that the costs inherent to the transaction be borne entirely by the Listuguj Mi'gmaq Government.
