Frank Sorbey –discusses the Land Claim settlement; he asks why are all the five properties together. Need to have Franklin Gertler clarify this question in further detail.

6. Christine Metallic – non- natives starting a business

C. Donna – recommends that non-natives starting a business in our community require an OIC.

7. Beverly Martin (Basque) – Gravel contract

A discussion was held regarding who was given the contract to haul gravel. Beverly voiced her concerns that it was given to a non-native. She was advised that it was a community member whom received the contract.

8. Kristy Isaac – RRAP

Council had a discussion about community members in need of a RRAP. Community members should be living in the community in order to receive RRAP.

9. Executive Director Paul Stanley

Paul S. - gives an update on the Le Centre Jeunesse file scheduled to be here on October 9, 2014. We would like to have some of the arguments thrown out. Ike Metallic file – Revenue Quebec has served his widow with a notice to continue the file in the name of the estate.
