## 13. Roles and Responsibility Mandate

Discussions on Council Roles and Responsibilities took place. Some council are requesting fulltime council positions and portfolios. It was agreed if any council were to have full time roles they should be out negotiating and advocating for the better of the community, and should be accountable for their work as well. Council agreed that the Listuguj Mi'gmaq Government is not ready for full time councillors at the moment and defining roles and responsibilities is key. August 1<sup>st</sup>, 2018 was agreed as a potential date to bring on a pilot project for portfolios and full-time council work.

#### 14. Sunpharm Investment Ltd Update

Delphine Metallic, Economic Development Manager presented to council an update on the Zenabis project as of date. It was indicated that the company is ready to do an equity raise. The deadline to convert the 3.3 million dollars is June 15, 2018 at the current price. A concern was brought forward that not enough consultation has been done with community, however was clarified that multiple community consultations took place over that past two years. Council was in support of converting the loan to shares however concerned with the deadline to make a decision. Council requested an extension until Monday, June 18, 2018 in order to read documentation and information provided on the file.

#### 15. <u>Update on Custom Election Code</u>
