WHEREAS: Listuguj Mi'gmaq Government is committed in expanding the Public Security Department and wishes to still send Cadets for training at the Atlantic Police Academy Holland College in Prince Edward Island in order to be eligible to a patrol officer in Listuguj

WHEREAS: In 2019-01-07 the Listuguj Police Department and Alog Simon signed a Training & Investment Agreement for Mr. Simon to attend, the twenty-six (26) week training course offered at the Academy in Summerside Prince Edward Island starting 2019-01-02, and graduating on 2019-08-30.

WHEREAS: The total cost of the training is \$31,144.00

WHEREAS: The cadet opted for living expenses while attending the Academy in the amount of \$350.00 weekly for twenty-six weeks (26).

WHEREAS: 2019-01-24 the Director of Finance brought forward the Holland College processed expenditure for Council authorization

WHEREAS: Council did not accept the expenditure because Mr. Simon is not a Listuguj Member

THEREFORE BE IT RESOLVED:

THAT: Due to the obligation between the Atlantic Police Academy Holland College and the Listuguj Mi'gmaq Government signed contract, Chief and Council will make a one time exception to approve the expenditure for Mr. Simon training program

THAT: Listuguj Police Department is to re-draft the Training & Investment Agreement to recover the cost of training for Mr. Simon

THAT: Mr. Simon, through his work with the Listuguj Police Department will repay the cost incurred for the training at the Atlantic Police Academy.

THAT: The Listuguj Police Department is to develop a policy for council approval, outlining the process for recurring and future cadets of the Listuguj Police Department

THAT: The Director of Finance has the mandate to sign and process the cost incurred for Alog Simon's Training at the Atlantic Police Academy
