WHEREAS the Listuguj Mi'gmaq First Nation is a Mi'gmaq community indigenous to Gespe'gewa'gi with a sacred, inherent responsibility for the stewardship of the land, waters, and living things of Gespe'gewa'gi;

WHEREAS the Mi'gmaq of Gespe'gewa'gi, including the Listuguj Mi'gmaq First Nation, have inherent rights, aboriginal title, aboriginal rights, and treaty rights to the lands, waters, and resources throughout Gespe'gewa'gi;

WHEREAS the Government of Canada and the Government of Québec have a constitutional duty to consult and accommodate the Listuguj Mi'gmaq First Nation whenever they contemplate conduct that may impact our rights, claims, and interests;

WHEREAS in June, 2012, the Micmacs of Gesgapegiag, la Nation Micmac de Gespeg, the Listuguj Mi'gmaq Government, the Government of Canada, and the Government of Québec signed the *Interim Tripartite Agreement on Mi'gmaq Consultation and Accommodation*, the purpose of which was to set out "a consultation process which may be used whenever Canada or Québec wishes to consult with the Mi'gmaq respecting any Aboriginal rights, including Aboriginal title, and treaty rights that the Mi'gmaq may have";

WHEREAS on November 12, 2018, the Listuguj Mi'gmaq Government and the Government of Canada signed the *Framework Agreement on Reconciliation and the Fishery*, which established a table to pursue bilateral negotiations between Listuguj and Canada regarding Listuguj's fisheries governance and fishing rights;

WHEREAS the Listuguj Mi'gmaq Government and the Government of Québec are currently engaged in bilateral negotiations regarding forest and wildlife management;

WHEREAS section 6 of the *Interim Tripartite Agreement on Mi'gmaq Consultation and Accommodation* provides that "a Chief and Council may notify Canada or Québec and the Mi'gmawei Mawiomi Secretariat Consultation and Accommodation Unit, in writing, at any time within the consultation process, that they wish to be consulted directly, rather than through the Mi'gmawei Mawiomi Secretariat Consultation and Accommodation Unit;"

NOW THEREFORE THE LISTUGUJ MI'GMAQ GOVERNMENT MAKES THE FOLLOWING ORDER-IN-COUNCIL:

- 1) That formal notice be provided to the Government of Canada, the Government of Québec, and the Mi'gmawei Mawiomi Secretariat Consultation and Accommodation Unit that as of the date of the present Order-in-Council the Listuguj Mi'gmaq Government wishes to be consulted directly, rather than through the Mi'gmawei Mawiomi Secretariat Consultation and Accommodation Unit, regarding all contemplated Crown conduct or decisions in relation to the following subject matters:
 - a. Fisheries
 - b. Forestry
 - c. Wildlife
