WHEREAS: On September 17, 2018, Listuguj Mi'gmaq Government Chief and Council approved Order in Council 2401 where they committed to the construction of (5) five lease to own homes.

WHEREAS: The Listuguj Mi'gmaq Government Chief and Council on October 10, 2017 committed to the construction/acquisition of (2) two Section 95 program housing units for the fiscal 2017-18

WHEREAS: Order in Council 2321 stipulates that the selection for Section 95 housing units will comply with the criteria described in the housing policy; and that it has been made known and is available to all member of the Listuguj Mi'gmaq community.

WHEREAS: On May 03, 2019 Chief and Council at a duly convened Chief and Council meeting adopted the HOUSING POLICY LMG – CWIH—HSG P—001 with a minimum of 120 days to implement

WHEREAS: Chief and Council determined it was beneficial to move forward with the five (5) lease-to-own housing units and two (2) Section 95 subsidized housing as the rentals were ready for occupancy

WHEREAS: HOUSING POLICY LMG – CWIH—HSG P—001 was not ready for Housing Selections

WHEREAS the Listuguj Mi'gmaq Government on June 18, 2019 held a duly convened Chief and Council Meeting to allocate five (5) lease-to-own housing units plus two (2) Section 95 subsidized housing rentals to select community members for the year 2019;
