Councillors are expected to participate in various meetings determined by the Office of Chief and Council, including, for example, the MM Meetings, MMBC Shareholder Meetings, AFNQL Meetings, AFN Meetings, etc.

WHEREAS it is deemed advisable by Chief and Council that Portfolios and/or Assignments (as defined in the attached "Working Conditions for Councillors of the Listuguj Mi'gmaq Government"), be assigned to each Councillor in order to ensure the proper discharge of LMG engagements and activities;

WHEREAS it is also advisable that the terms and conditions of the execution of Assignments and the Councillors' duties and responsibilities in respect thereto, the meeting attendance requirements, the relevant honorarium in each case, the annual paid leave, the insurance coverage and other working conditions of Councillors be defined and consistently applied;
