WHEREAS: Tendering process has begun on September 25, 2019 for the Lagoon sludge removal in accordance with the LMG Tender Policy

WHEREAS: Opening of tender took place on October 22nd 10 am Atlantic time at 44 Dundee Road Natural Resource Building

WHEREAS: Two tenders were submitted to the Listuguj Mi'gmaq Government as follows:

- Revolution Environmental Solutions LP (TerraPure) submitted a price of \$292 160 and received a final score of 100%
- Excent Environment submitted a price of \$423 000 and received a final score of 69.68%

WHEREAS: The department of Capital and Infrastructure recommended to award the contract to Revolution Environmental Solutions LP (TerraPure) for a price of \$292 160 (Lowest Bidder).

WHEREAS: Total cost will be shared as per the original agreement executed in 1999 between LMG and Pointe a la Croix Municipality.

WHEREAS: The cost sharing from the original agreement is 38,84% for Pointe a la Croix and 61,16% for Listuguj as per article 8.2 in the original agreement signed in 1999. Listuguj should have put \$2,604.22/year for Pointe-à-la-Croix's share based on the original agreements into a fiduciary account.
