WHEREAS, the Chief and Council of the Listuguj Mi'gmaq Government (LMG), in the Province of Quebec, act for and on behalf of the members of the Listuguj First Nation and are empowered to exercise such powers as set out in the *Indian Act* and other applicable legislation.

WHEREAS, a quorum of Council has met at a duly convened meeting at the Listuguj Mi'gmaq Council Chambers located at 17 Riverside West in Listuguj, QC.

WHEREAS, Order-In-Council Number 1732, dated March 06, 2008, titled, Housing Selection 2008, identified John Dedam, Band Number 587 as being a recipient of a "Lease to Own" home to be situated at 28E Gaspé Highway in Listuguj Quebec.

WHEREAS, Order-In-Council Number 1862, dated June 08, 2010, titled, Housing Selection 2008, revision number 2, affirms that John Dedam, Band Number 587 as a recipient of a "Lease to Own" home to be situated at 28E Gaspé Highway in Listuguj Quebec.

WHEREAS, on October 16, 2009, John Dedam, Band Number 587 became deceased.

WHEREAS, before, October 16, 2009, John Dedam, Band Number 587 and the LMG did not execute a contract for the abovementioned home which is presently constructed at 28E Gaspé Highway.

WHEREAS, the LMG hereby authorizes and approves the transfer of the noted home at 28E Gaspé Highway, to Bernard Isaac, Band Number 1145.

BE IT THEREFORE RESOLVED THAT the LMG authorizes and approves the transfer of the "Lease to Own" home at 28E Gaspé Highway to Bernard Isaac, Band Number 1145; and

BE IT ALSO RESOLVED THAT the LMG and Bernard Isaac, Band Number 1145 shall enter into a contract for the payment of the "Lease to Own" home situated at 28E Gaspé Highway subject to separate negotiations between the LMG and Bernard Isaac, Band Number 1145.
