THAT

THAT

The immediate needs of the Listuguj Mi'gmaq Government are for Six Hundred and Eighty Thousand Dollars (\$680,000.00) and construction of Eight (8) units shall be commenced in the 2012-2013 fiscal year, and will be built to meet or exceed the National Building Code (NBC) standards or equivalent standards.

Financing will be as follows:

Departmental Appropriation Loan by Royal Bank of Canada	\$ 300,000 \$1,000,000
Total Cost Total number of units: Ten (10)	\$1,300,000
Average cost per new Housing Unit \$	\$ 130,000

THAT The loan amount of Six Hundred and Eighty Thousand Dollars (\$680,000.00) will be amortized over a period of 25 (twenty five) years (not to exceed 25 years) at an interest rate of Three point Five percent (3.50_%) determined by the Listuguj Mi'gmaq Government and the Royal Bank of Canada insured by Canada Mortgage & Housing Corporation pursuant to the terms of the NHA. The monthly payments on the loan will be made by the Council of the Band.

THAT The houses will remain the property of the Council of the Band and the occupants, all of whom are band members, shall make rental payments to the Council of the Band on a rent according to income formula, and any shortfall will be met from the Band's revenues.

THAT The Council of the Band will engage the services of a qualified firm of auditors who will set up a system of records and accounting and who will perform an annual audit of the books and other records relating to the housing program. Such audit shall coincide with the Federal Government's fiscal year and the audit report must reach regional offices no later than July 30th, of each year.

THAT All books and records of the housing program will be accessible at all times to the department or to an auditor appointed by the Department.

> The Council of the Band will open a separate bank account and/or a separate and distinct record of accounting, wherein only monies related to the First Nations' Housing Program, including all payments made by the occupants, will be deposited. This account will be known as the Listugui Mi'gmaq Government Trust Account.

THAT Insurance will be carried on the housing units.

THAT The Council of the Band shall be responsible for the ordinary maintenance and minor repairs on the houses.

THAT

Where under section 10 and 12 of Schedule "A" of the Terms and Conditions for Ministerial Loan Guarantees, as approved by OIC P.C. 1999-2000, dated November 4, 1999, the Minister has paid a claim to the Lender on a Loan Guarantee, the Council of the Band will negotiate a repayment agreement with the Minister for any payment made by the Minister to the Lender.

Where section 89 of the Indian Act is applicable, the Council of the Band shall provide Her Majesty in Right of Canada with a waiver to the application of section 89 with respect to assets other than land. The authority conferred herein is irrevocable.

THAT

Where under Sections 4, 5 and 6 of Schedule "A", Terms and Conditions as approved by OIC P.C. 1999-2000 of November 4, 1999:

- the Council of the Band and the existing Lender agree to renew an existing loan for another term;
- the Council of the Band and the existing Lender agree to refinance an existing loan;
- (iii) the Council of the Band transfers the loan to a new Lender; or
- (iv) the Lender assigns the loan to a new Lender,

the Council of the Band will continue to assume the responsibilities under the Loan Agreement (No. ______) or the Guarantee Agreement (No. ______), as set out in Schedule "A", Section 12 ("Recovery on Defaulted Loans") in the Terms and Conditions for Ministerial Loan Guarantees, as approved by O.I.C. P.C. 199-2000 dated November 4, 1999.
