This also extends to the Quebec Archives and the Library and National Archives of Quebec.

Whereas, Listuguj Mi'gmaq Government (LMG) operates a commercial fishery pursuant to the Marshall case, 1999; and

Whereas, the own-source revenues generated by this activity are significant and important to the overall economy and well-being of the community; and

Whereas, this activity generates gross revenue in excess of 7 million dollars; and

Whereas, the current governance structure consists of: Director, Fisheries Coordinator, Database Entry Clerk/Finance as the core administrative staff; and

Whereas, the LMG possess licenses a variety of species including: snow crab, shrimp, lobster, rock crab, cod, greenland halibut, atlantic halibut and a mussel farm operations; and

Whereas, the LMG possess 11 fishing vessels and employs approximately 70 individuals to carry out the fishing activities; and

Whereas, the current Director of Fisheries is taking an academic leave of absence until June 13, 2014 or in the event that she returns earlier, she will provide a three-week notice to Chief Vicaire of her intention; and

Whereas, the Director of Fisheries presented a report to council on August 26, 2013 with the following objectives:

- Oversee the development of a repackaging facility
- Pursue marketing initiatives
- Fishery Governance incorporation
- Research Drug testing feasibility
- Explore new fisheries (scallops)

Whereas, it is recommended that Dr Fred Metallic be appointed as Acting Director of Fisheries during the current Director's absence and that he will relocate his office to the Natural Resource building; and

Therefore, be it further resolved that the "Recommendation for a Temporary Replacement to Director of Fisheries" dated August 26, 2013 be approved.
