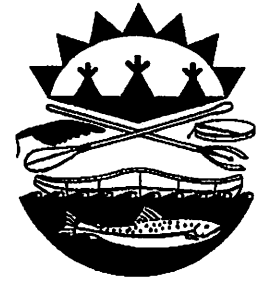


Listuguj Mi'gmaq Government Order-In-Council

WHEREAS the Listuguj Mi'gmaq Government is the legal governing body of the Mi'gmaq of Listuguj and their territory

WHEREAS following spring 2018 flood approximately 58 houses were flooded within the surrounding of the community

WHEREAS it was identified that the interprovincial road blocking the storm water from flowing to its natural drainage pass toward the tributary branch of Monier Creek

WHEREAS it was identified the requiring of installing a storm water culvert under the interprovincial boulevard to restore this natural flow path to prevent drainage and flooding issues that have been happening in the area in the last decades causing sever consequences .

WHEREAS meetings were held in 2018, 2019 and 2020 with representatives of the Ministère des Transport du Québec (MTQ) and to discuss about the recurrent flooding issue at this area,

WHEREAS the Listuguj Mi'gmaq Government had a hydraulic study and plans prepared by Crandall, a division of Englobe Corp to implement a mitigation measure that require the restoration natural drainage pass toward the tributary branch of Monier Creek

WHEREAS the MTQ operate the Interprovincial Boulevard crosses the Listuguj territory;

WHEREAS flooding is likely to recur in the spring of 2020

WHEREAS, a future flood constitutes a serious risk for civil security;

THEREFORE BE IT RESOLVED that the Listuguj Mi'gmaq Government asks the MTQ to install a culvert under the Interprovincial boulevard as soon as possible to avoid any future damages;

IT IS FINALLY RESOLVED that this resolution shall take effect immediately upon signing by Chief and Council.
