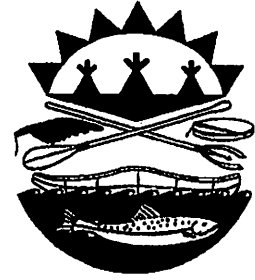

WHEREAS, the Listuguj Community Health Services (LCHS) is mandated to deliver quality programs and services to support the Vision and Mission of the LMG; and

WHEREAS, the Canadian Aboriginal AIDS Network, Inc., (CAAN) is a national non-profit coalition of individuals and organizations that provide leadership, support and advocacy for Aboriginal people living with and affected by HIV/AIDS and Hepatitis C regardless of where they reside; and

WHEREAS, the philosophy of CAAN is in line with that at the LMG in that Aboriginal people deserve the right to protect themselves against infectious disease; and

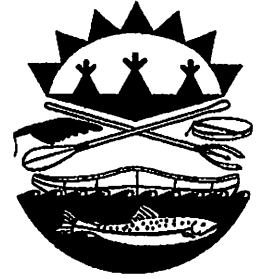

WHEREAS, the LCHS has entered into a Memorandum of Understanding (MOU) with CAAN to undertake Community Readiness Training; and

WHEREAS, the purpose of the MOU is to formalize organizational interest in potential areas of mutual collaboration between CAAN and Listuguj toward supporting the integration of HIV, Hepatitis C and/or STBIs towards a 90-90-90 goals;

BE IT THEREFORE RESOLVED that the Listuguj Mi'gmaq Government Council approves and fully supports the working relationship between the Listuguj Community Health Services and the Canadian Aboriginal AIDS Network, Inc.; and

BE IT FURTHER RESOLVED that the Listuguj Mi'gmaq Government Council mandates the Listuguj Community Health Services with the responsibility for the development and implementation of Community Interventions and Strategies that target Harm Reduction for our community members.
