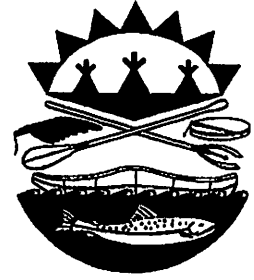

Whereas, Listuguj's Economic Development Unit is in the process of developing a Listuguj Tourism Strategic Plan to properly plan, develop and identify tourism projects and partnership opportunities with private and public sectors; and

Whereas, the Battle of Restigouche would like to collaborate with the Listuguj Mi'gmaq Government to explore opportunities that will benefit both Listuguj and Parks Canada in terms of heritage and cultural presentation, tourism and economic development; and

Whereas, the Battle of Restigouche site is right in the middle of the newly acquired ATR lands; and

Whereas, taking advantage of newly acquired ATR lands for growing and enhancing tourism, culture and economic development has been identified in the Economic Development Strategic Plan, Comprehensive Community Plan, Listugujewei Land Use Plan and Community Master Development Plan; and

Whereas, there are various ways in which Listuguj can enhance their presence at the Battle of Restigouche site including but not limited to the following processes: A Rights and Reconciliation Agreement, Indigenous Peoples Open Door Program, Addition to Reserve or a Co-management process; and

Whereas, a working group is to be formed made up of key members of the community to gather relevant information, to explore and analyze all possible options and to bring information back to council to make an informed decision on whether LMG would like to negotiate for full, partial or no responsibility in enhancing the Mi'gmaq presence at the Battle of Restigouche; and

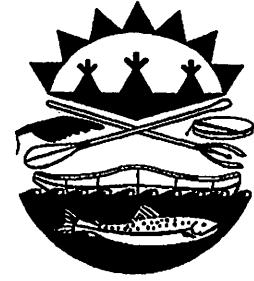
