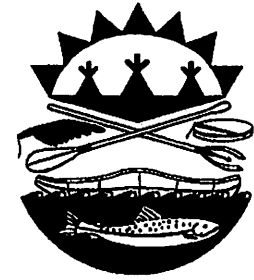

WHEREAS, effective emergency management starts at the local level; and

WHEREAS, when there is an actual or impending emergency that could threaten life, property or the environment, the Chief and Council are responsible for using all available local resources to respond, and

WHEREAS, Chief and Council are also responsible for notifying Indigenous Services Canada (ISC) and provincial emergency management officials if a threat is beyond their community's response capacity; and

WHEREAS, ISC encourages First Nation Communities to create and implement emergency management plans; and

WHEREAS, the Listuguj Mi'gmaq Government is one of 29 First Nation Communities to take part in the ISC Quebec Region funded Emergency Management Assistance Program; and

WHEREAS, Chief and Council Members are responsible for providing good government, responding to the needs of the People, as well as, fostering unity and self-sufficiency in the Listuguj Mi'gmaq First Nation; and

WHEREAS, it is the Mission of the Administration of the Listuguj Mi'gmaq Government to deliver the best possible services and programs in accordance with the policies and budgets approved by the Council; and

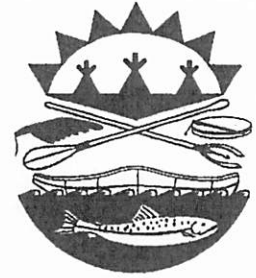

WHEREAS, it is stated in Principle #4 of the Organizational Principles of the Listuguj Mi'gmaq Government that the Staff functions are organized and structured in a manner which allows the available personnel to best meet the requirements of the Listuguj Mi'gmaq Government, which is designed to promote the effective management of personnel and resources; and

WHEREAS, the Staff of the Listuguj Mi'gmaq Government require a formal structure and forum in which to share information, resources and ideas to support and guide the programs and services within the community to meet Principle #4 of the Organizational Principles of the Listuguj Mi'gmaq Government; and

WHEREAS, in order to effectively coordinate and compliment the programs and services offered to the People of Listuguj by non-governmental groups and/or agencies during an Emergency situation, the Staff of the Administration need to establish a formal link to these groups and agencies;

BE IT THEREFORE RESOLVED that the Listuguj Mi'gmaq Government Council approves the development of an inter-Directorate Committee between Public Security, Health Services and Capital & Infrastructure to coordinate the protocols and logistics that may be required by Chief and Council to effectively respond to an emergency at the community level; and

BE IT FURTHER RESOLVED that the Title of the Committee shall be the Listuguj Mi'gmaq Government Emergency Management Committee. The Mission of the Committee will be to ensure that processes and procedures are in place to immediately enact appropriate measures in response to various community-wide emergency situations; and

BE IT FURTHER RESOLVED that Chief and Council approve the delegation of authority to the Emergency Management Coordinator and Emergency Management Committee to take immediate and appropriate action during a catastrophic event that preserves lives, safeguards property and protects our environment; and

BE IT FURTHER RESOLVED that only the Chief, or his delegate, can declare an official 'State of Emergency' in Listuguj based on the recommendation and support of the Listuguj Emergency Operations Center Incident Commander; and

BE IT FURTHER RESOLVED that the Mandate of the LMG Emergency Management Committee will focus on ensuring an up-to-date Emergency Preparedness Plan is completed/updated and communicated with the appropriate local, provincial and federal agencies.
