

WHEREAS the Listuguj Mi'gmaq First Nation is a Mi'gmaq community indigenous to Gespe'gewa'gi with a sacred, inherent responsibility for the stewardship of the land, waters, and living things of Gespe'gewa'gi;

WHEREAS the Mi'gmaq of Gespe'gewa'gi, including the Listuguj Mi'gmaq First Nation, have existing treaty and Aboriginal rights with respect to fisheries;

WHEREAS on August 4, 2000, Listuguj, Gesgapegiag, and Gespeg signed a political accord (the "Political Accord") establishing a joint assembly—the Mi'gmawei Mawiomi—that enables the Communities to work together in dealing with matters of common concern;

WHEREAS the Political Accord is clear that "the Mi'gmaq enjoy and exercise the inherent right of Self-Government" and that the Political Accord "will in no way, shape or form hinder the communities of Gespgapegiag, Gespeg and Listuguj in being autonomously governed by their respective Chiefs and Councils;"

WHEREAS on November 12, 2018, Listuguj and Canada signed the Framework Agreement on Reconciliation and the Fishery ("Framework Agreement"), which established a table to pursue negotiations between Listuguj and Canada regarding the Listuguj's fisheries governance and fishing rights ("Community Negotiations Table");

WHEREAS by Order-in-Council of the Listuguj Mi'gmaq Government #2425 the Listuguj Fisheries Negotiation Team was appointed as the sole authorized representative of Listuguj for the purposes of conducting negotiations with Canada regarding Listuguj's fisheries, and the LMG's Natural Resource Director was appointed the LMG's Lead Fisheries Negotiator;

WHEREAS Canada recently introduce the Treaty Related Measures ("TRMs") program to provide funding to Mi'kmaq and Maliseet First Nations aggregates to design and test their visions of fisheries governance in advance of negotiating and concluding a Rights Recognition Agreement ("RRA") with Canada;

WHEREAS representatives of Listuguj, Gesgapegiag, Gespeg, and Canada negotiated the attached Memorandum of Understanding regarding Treaty Related Measures with the Mi'gmaq in Québec to enable Listuguj, Gesgapegiag, and Gespeg to enter into TRM funding agreements with Canada in a manner that respects each community's autonomy and reflects the Political Accord;

## NOW THEREFORE THE LISTUGUJ MI'GMAQ GOVERNMENT MAKES THE FOLLOWING ORDER-IN-COUNCIL:

- The LMG's Natural Resources Director, in his capacity as the LMG's Lead Fisheries Negotiator, is authorized to:
  - a. sign the Memorandum of Understanding Regarding Treaty Related Measures with the Mi gmaq in Québec on behalf of the LMG; and
  - b. take necessary action to develop a Treaty Related Measures project proposal and to negotiate a Treaty Related Measures contribution agreement with Canada.
