WHEREAS: Caplin Road and surrounding areas have been subject to flooding for years.

WHEREAS: The Listuguj Mi'gmaq Government along with the Capital & Infrastructure Department, have been working with various consultants to find the optimal solution to solve the problem.

WHEREAS: LMG and Capital & Infrastructure successfully obtained funding from Department of Indigenous Service Canada (DISC) in February 2019, in order to fund this vital project design and construction. This includes the funding of previous studies and analysis related to the project.

WHEREAS: The project consists of several contracts; total estimated cost of the contracts is \$6,900,000.

WHEREAS: The first contract that includes the drainage work of Caplin Road, for an estimated cost of \$2,500,000, was posted for tender on July 8, 2020.

WHEREAS: The tender opening took place on July 24th, 2020, and was administrated by the project consultant Englobe Corp. A single bid was submitted from Wejuseg Construction Inc. for a total cost of \$2,466,539.

WHEREAS: The project consultant recommended to award the contract to the only compliant bid from Wejuseg Construction Inc., for a total cost of 2,466,539.

THEREFORE: LMG and Capital & Infrastructure recommend awarding the contract to Wejuseg Construction Inc.
