WHEREAS the Chief and Council consider it necessary to establish a framework of working conditions applicable to Councillors currently in office during their term of office commencing November 7, 2020 and ending at the next general election;

WHEREAS it is deemed advisable by Chief and Council that Files and/or Assignments (as defined in the attached "Working Conditions for Councillors of the Listuguj Mi'gmaq Government"), be assigned to each Councillor in order to ensure the proper discharge of LMG engagements and activities;

WHEREAS it is also advisable that the terms and conditions of the execution of Files and Assignments and the Councillors' duties and responsibilities in respect thereto, the meeting attendance requirements, the relevant honorarium in each case, the annual paid leave, the insurance coverage and other working conditions of Councillors be defined and consistently applied;

THEREFORE, BE IT RESOLVED THAT

THAT: Councillors who are employees of the Listuguj Mi'gmaq Government who attend Council Meetings and other various meeting determined by the Office of Chief and Council will be authorized to be absent from their regular duties as employees of Listuguj Mi'gmaq Government with pay and without having to use any vacation time, sick time, overtime or holidays with no exception. The said councillor must notify in writing as soon as possible their supervisor with regards to their participation in such meetings.














THAT the attached "Working Conditions for Councillors of the Listuguj Mi'gmaq Government" are hereby adopted and approved;
