WHEREAS in September 2008, the Mi'gmawei Mawiomi (Gesgapegiag, Gespeg and Listuguj) signed the Niganita Suatas'gl Ilsutaqaan with Canada and Québec by which they agreed to enter into a process with the common purpose and objective of identifying their respective issues and interests in developing a relationship of reconciliation and coexistence.

WHEREAS in June 2012, the Niganita Suatas'gl Ilsutaqaan process evolved into the Niganiljo'gataqaan, a framework agreement where subject matters, such as natural resources were listed as potential items for negotiations between the Mi'gmawei Mawiomi, Canada and Québec.








WHEREAS the Nutewistog identified the need to work more closely with the Councils of Gesgapegiag, Gespeg and Listuguj for the purpose of ensuring that bipartite and tripartite negotiations evolve in accordance with the mandates adopted by the MM and the needs and aspirations of Mi'gmaq citizens in Gespe'gewa'gi.

WHEREAS the Nutewistog recommended to the MM, that a steering and technical committee be re-established to support and guide the work of the Mi'gmaq Mgnigng.

WHEREAS the Nutewistog explained that the STC could also serve the purpose of facilitating political and citizen engagement by ensuring a collaborative approach between the Mi'gmaq Mgnigng, the Mi'gmaq communities and the councils of Gesgapegiag, Gespeg and Listuguj.

WHEREAS the MM supported the re-establishment of the STC and suggested that the first order of business of the STC would be to focus on the content of the tripartite framework agreement (Niganiljo'gata'qan) and to build a governance mechanism related to the intergovernmental relations of Gesgapegiag, Gespeg and Listuguj.

BE IT RESOLVED that the Listuguj Mi'gmaq Government hereby supports the re-establishment of the Mi'gmawei Mawiomi Steering and Technical Committee.

BE IT FURTHER RESOLVED THAT Councillor Cathy Martin, Councillor Alexander Morrison and Councillor Sky Metallic (ex-officio member) be appointed to represent the Listuguj Mi'gmaq Government at the MM Steering and Technical Committee.

BE IT FINALLY RESOLVED THAT Ms. Ali Barnaby be appointed as the youth representative and John Isaac as Elder representative.
