- WHEREAS** We, the Listuguj Mi'gmaq Government (LMG), strongly believe in our culture and tradition, our aboriginal and treaty rights, and most of all, our People; and
- WHEREAS** We stand by our Vision "Getlamite'tmeg enmina'qeg ugjit wejgwapegsultijig"; and
- WHEREAS** Listuguj Chief and Council passed OIC #2483 to reiterate their commitment to building an Elders facility "Waqatasq Seniors Home" to meet the specific needs of our community; and
- WHEREAS** The design of Waqatasq Seniors Home is completed and ready for tendering; and
- WHEREAS** The Construction Cost Estimate (Class A) is \$ 10,810,00 (Ten Million, Eight Hundred and Ten Thousand)
- WHEREAS** LHCS continue to work with CMHC to provide the funding for the project; and
- WHEREAS** On Sept. 15, 2020, CMHC has provided a letter of Intention for their approval on the loan of amount \$ 7,729,229.00 (Seven Million Seven Hundred Twenty-Nine Thousand Two Hundred Twenty-Nine Dollars) with low interest rate and amortization period of 25 years, in addition to a contribution of amount \$ 1,298,065.00 (One Million Two Hundred Ninety-Eight Thousand Sixty-Five Dollars), subject to satisfying some conditions; and

WHEREAS Two of CMHC's conditions are that LMG to confirm to provide initial contribution and funds to cover part of the annual operation budget;

BE IT RESOLVED that Listuguj Chief and Council confirm to provide the following required sums upon CMHC approval;

- Initial Contribution of an amount \$ 1,950,000.00 (One Million Nine Hundred Fifty Thousand Dollars), plus the cost of the land of an amount \$200,000 (Two Hundred Thousand Dollars).
- Funds to cover part of the annual operation budget during the amortization period of the project of the co-investment agreement.
