WHEREAS her Majesty the Queen in RIGHT of CANADA as represented by the Minister of Public Security and Emergency Preparedness herein referred to as (CANADA)

WHEREAS the Government of Quebec as represented by the Sous-Minister de la Securite Publique herein after referred to as (QUEBEC) and herein after referred to as (2020 COVID Amendment)

WHEREAS the expenditure period from April 1, 2020 to March 31 2021 to include in Schedule A, of which a maximum of \$1345,408.16 for expenditures related to COVID 19.

WHEREAS, where applicable, the agreement includes any previous amendments made by way of an amendment signed by the Parties;

WHEREAS the Parties wish to amend again the agreement, in accordance with subsection 6.3 of this agreement, to add non-recurring exceptional funding in light of the specific situation resulting from the COVID-19 pandemic response to cover expenses for the period from April 1, 2020 to March 31, 2021;

WHEREAS this funding is distinct from the funding for policing operating costs set out in Schedule A of the Agreement and covers the expenditure eligibility period from April 1, 2020 to March 31, 2021;













THEREFORE BE IT RESOLVED:
