- WHEREAS** the Listuguj Mi'gmaq Government is the legal governing body of the Mi'gmaq of Listuguj and their territory; and,
- WHEREAS** the COVID-19 crisis has exacerbated existing housing affordability and homelessness issues particularly for the most vulnerable population; and
- WHEREAS** the Listuguj Mi'gmaq Government wish to implement the Rapid Housing Initiative ("RHI") to rapidly house some of the most vulnerable peoples in the Listuguj territory; and
- WHEREAS** Canada Mortgage and Housing Corporation (CMHC) have approved funding for 16 affordable housing unit:
- 10 single unit houses completed by August 20, 2021
 - 2 Triplex units completed by July 31, 2021; and
- WHEREAS** To ensure CMHC funding, first occupancy of the housing units must take place within the first 3 months of the project effective date of the 3rd day of March, 2021; and
- WHEREAS** An architect has been hired to provide detailed designs for both the triplex and single unit homes; and

That Listuguj Chief and Council approve to authorize the Chief Executive Officer and the Capital and Infrastructure department to do the necessary action to obtain the fund of \$ 2,610,104 dollars as outlined in the attached CMHC confirmation agreement for construction of the 16 affordable housing units, and

- That Listuguj Chief and Council commit to contribute with an amount of \$ 355,923 dollars through the LMG Own-Sourced Revenue (OSR) financial reserve.
