**WHEREAS:** the Listuguj Mi'gmaq Government (the "LMG") filed application for judicial review No. T-1722-19 in Federal Court (the "Application") against the decisions made by the Minister of Fisheries and Oceans (the "Minister") on September 23, 2019, to issue fishing licence number LMFN-2019-FF01 and on September 18, 2020, to issue fishing licence number LMFN-2020-FF01, which included licence conditions prohibiting the sale of lobster caught during the LMG's fall 2019 and 2020 fisheries;

**WHEREAS:** on April 16, 2021, the LMG and Canada concluded the Rights Reconciliation Agreement on Fisheries (the "RRA"), which, among other things, aims to provide recognition and implementation of the Listuguj Mi'gmaq First Nation's aboriginal and treaty rights in relation to fisheries governance and fishing as well as acknowledgment of the LMG's laws in relation to its fisheries;

**WHEREAS:** following collaborations between the LMG and Canada as contemplated in the RRA aimed at implementing the LMG's fishing activities in a manner that is consistent with the Listuguj Mi'gmaq First Nation's aboriginal right, treaty rights, interests, and internal governance, on September 23, 2021, the Minister issued fishing licence number 903439, which included licence conditions permitting the sale of lobster caught during the LMG's fall 2021 fishery;
