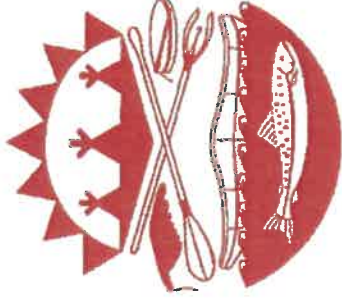

**WHEREAS:** the Economic Development Unit has identified through the Economic Development Strategy and Comprehensive Community Planning, the need to further explore tourism initiatives within the territory;

**WHEREAS:** the Listuguj Mi'gmaq Government supported the development of the Listuguj Tourism Strategic Plan through Order-in-Council #2451 in May 2019;

**WHEREAS:** the Tourism Development Officer along with a consultant engaged the community in a variety of focus groups (youth, elders, business owners, cultural knowledge keepers, general public) to discuss ideas and priorities that would determine the strategies in the tourism plan;

**WHEREAS:** the Listuguj Tourism Strategic Plan includes a current assessment of Listuguj, assessment of tourism in the region, a SWOT (Strengths, Weaknesses, Opportunities, Threats) analysis, priority actions based on community feedback and an implementation plan;

**WHEREAS:** the priority action pillars are as follows: 1) New Product Development, 2) Improve Existing Products, 3) Marketing & Communications, 4) Leadership & Resources;

**WHEREAS:** two priority projects were identified to undergo pre-feasibility studies, namely 1) Listuguj Visitor Center and 2) Listuguj Nature Park Glamping site, for the purpose of creating a tourism hub and providing accommodations so visitors could enjoy the area further, all the while enhancing the economic opportunities for the community;
