BE IT ALSO RESOLVED

THAT: the Listuguj Mi'gmaq Government commits to the following:

1. Complete the project(s) within the time frame as defined in the proposal form.
2. Conform to the parameters and categories of eligible investments as defined in the On-Reserve and Community Housing Initiative 2021-2024.
3. Comply with all federal and provincial environmental laws and regulations that may apply to the project(s).
4. Use a fair and transparent process to allocate funds and assign units for renovation and/or construction projects for the greatest local needs so that investments meet the parameters and criteria of the Initiative.
5. Ensure the financial viability of construction projects.
6. Certify that all housing units constructed will meet, at a minimum, the 2015 National Building Code (NBC) standards or any other recognized code, equivalent or better, used locally. The First Nation agrees to maintain records of inspections and compliance with NBC and other relevant standards and to share a copy with the Department upon request.
