WHEREAS: Her Majesty the Queen in RIGHT of CANADA as represented by the Minister of Public Security and Emergency Preparedness herein referred to as (CANADA).

WHEREAS: the GOUVERNEMENT of QUÉBEC represented by the Ministre de la Sécurité publique, the Ministre responsable des Affaires autochtones and the Ministre responsable des Relations canadiennes et de la Francophonie canadienne, respectively acting by the Sous-ministre de la Sécurité publique, the Secrétaire général associé aux Affaires autochtones and the Secrétaire général associé aux Relations canadiennes (hereinafter referred to as “Québec”)

WHEREAS: the Listuguj Mi'gmaq Government (hereinafter referred to as “Council”), Canada and Québec have entered into the Agreement on the Provision of Police Services in the Community of Listuguj for the period of April 1, 2018, to March 31, 2025 (hereinafter referred to as “Tripartite Agreement 2018-2025”).

WHEREAS: under the terms of the “Tripartite Agreement 2018-2025”, the Council is responsible for the Listuguj Police Service, which provides policing services in the territory defined therein.

WHEREAS: the Council, Canada, and Quebec, are all in agreement that there is a need for upgraded policing infrastructure within the community of Listuguj.

WHEREAS: Council, Canada, and Québec, while respecting their own jurisdictions, wish to improve the safety and well-being of the occupants of policing facilities used by the “Listuguj Police Service” by entering into a funding agreement for policing infrastructure within the community of Listuguj.

WHEREAS: the funding agreement for policing infrastructure will minimally affect the “Tripartite Agreement 2018-2025”.

WHEREAS: the current “Tripartite Agreement 2018-2025” (Policing Services Agreement), the Council will not be able to claim the cost of occupancy (rent) without the prior approval of Canada and Québec.

AND WHEREAS: the building care and maintenance costs for the policing facility funded by this police infrastructure agreement are still eligible.

THEREFORE BE IT RESOLVED:

THAT: Chief and Council do hereby authorize Chief Darcy Gray to act as signing authority for the Listuguj Mi'gmaq Government Agreement on the Funding of Policing Infrastructure for the Community of Listuguj and/or Interim Chief Executive Officer, Jeff Basque and or/ Director of Public Security, Peter Arsenault.
