**WHEREAS:** The Listuguj Mi'gmaq Government wishes to construct a Healing Lodge and Language/Cultural Centre—Turtle Lodge, to provide a safe space for all community members who seek traditional healing; support Mi'gmaq language, cultural and ceremonial initiatives within the community, facilitate crime prevention and reduction of poverty and addictions;

**WHEREAS:** The Listuguj Mi'gmaq Government successfully obtained funding commitment in the amount of \$1,150,000 (One Million and One Hundred and Fifty Thousand) through Crown-Indigenous Relations and Northern Affairs Canada;

**WHEREAS:** LMG issued a called for proposal for the Design of of the Healing and Language/Culture Centre—Turtle Lodge.

**WHEREAS:** The Tender Opening took place on April 26, 2022;

**WHEREAS:** Two proposals were received at or before the closing time as followed:  
Anicet Tremblay et Serge Harvey, Architects Inc. (Ashini Consultants) for \$258,500  
Caron Lagace Architecture and Design Inc. (CLAD Inc.) for \$210,000;
