WHEREAS the Listuguj Mi'gmaq First Nation Community Social Services Directorate (LCSSD) was mandated by the Listuguj Mi'gmaq Government to design, plan, manage and deliver social services and rehabilitation services to the Listuguj Mi'gmaq Government;

WHEREAS, under the terms of the legislation governing the delivery of health and social services in Québec, specifically Articles 82 and 84 of the Act respecting health services and social services (L.R.Q., c. S-4.2), the mission of the CISSS de la Gaspésie is to provide psychosocial and rehabilitation services within its region;

WHEREAS there is an existing interim agreement, signed on January 26, 1996 by the LCSSD and the Centre jeunesse concerning the sharing of specific responsibilities, coordination and cooperation in the delivery of social services;

WHEREAS there is also an existing interim agreement, signed on November 1, 1996, by the Gesgapegiag Band Council and the Centre jeunesse, concerning the sharing of specific responsibilities, coordination and cooperation in the delivery of social services;

WHEREAS the LCSSD and the CISSS de la Gaspésie wish to enter into an interim or transitional administrative agreement concerning rehabilitation services and the sharing of responsibilities for the Gignu Rehabilitation Unit, which are part of their legal mandate;

WHEREAS the CISSS de la Gaspésie, with due respect for the legislation that governs its activities, must continue to assume responsibility for the management and delivery of rehabilitation services to children and youths until such time as the relevant authorities have signed a sectoral agreement concerning the complete handover of responsibilities for the management of the Gignu Rehabilitation Unit to the LCSSD;

WHEREAS this agreement includes all the provisions required to clarify the roles and responsibilities of each party in the delivery of rehabilitation services as well as in administrative and financial activities, as well as the attached annexes and collective agreement;

THEREFORE BE IT RESOLVED

That Chief and Council approve the service agreement with the CISSS and repayment plan for outstanding balances owed to Centre Jeunesse.

BE IT FURTHER RESOLVED

That Chief and Council do hereby authorize Chief Darcy Gray to act as a signing authority for both the service agreement and the debt repayment plan on behalf of the Listuguj Mi'gmaq Government.
