WHEREAS the Chief and Council of Listuguj Mi'gmaq Government, on behalf of the Listuguj community, wish to understand our vulnerability to the social and physical well-being of our community members brought on by climate change;

AND WHEREAS, Health Canada, First Nations and Inuit Health Branch, has funding available through the Climate Change and Health Adaptation Program for Southern First Nations;

AND WHEREAS, the Gespe'gewa'q Mi'gmaq Resource Council, representing the community of Listuguj, is a First Nation non-profit organization concerned with aquatic and environmental issues and their impact on community members;

AND WHEREAS, the Gespe'gewa'q Mi'gmaq Resource Council has the capacity to conduct community-based research projects and manage the flow of information between the community of Listuguj and its members on the findings;

THEREFORE, BE IT RESOLVED that the Chief and Council of the Listuguj Mi'gmaq Government support the funding application titled, *Pemsa'se'wigisg'g*, prepared by the Gespe'gewa'q Mi'gmaq Resource Council on behalf of the community of Listuguj regarding the Climate Change and Health Adaptation Program for Southern First Nations provided through Health Canada, First Nations and Inuit Health Branch.

BE IT FURTHER RESOLVED that the Gespe'gewa'q Mi'gmaq Resource Council will administer the logistics of the *Pemsa'se'wigisg'g* project as outlined within the proposal on behalf of the Listuguj Mi'gmaq Government.

BE IT FURTHER RESOLVED that the Gespe'gewa'q Mi'gmaq Resource Council will be the primary recipient for the funding received to carry out this project, and will be responsible for all reporting requirements as outlined in the Contribution Agreement between Health Canada and the Gespe'gewa'q Mi'gmaq Resource Council.
