Whereas the Indigenous and Northern Affairs Canada, the Lands and Economic Development Services Program (LEDSP) promotes and supports communities to enhance their economic development, land and environmental capacity and supporting; and

Whereas, the LEDSP also supports communities in their pursuit of and participation in the economy; and

Whereas, the funding allocations supports Listuguj's desire to take on a broad scope of land and environmental responsibilities, including land use planning; and

Whereas the Listuguj Mi'gmaq Government submitted a proposal to the Indigenous and Northern Affairs Canada to develop a community land use plan; and

Whereas, the Listuguj Mi'gmaq Government has successfully obtained funding to undertake a community land use plan for a maximum fixed contribution of \$300,000 over a three year period as follows:

- \$75,000 2016-2017
- \$225,000 2017-2018 (subject to fund availability)
- \$225,000 2018-2019 (subject to fund availability); and

Whereas the land use plan will ensure that Listuguj has an orderly land use plan and will be efficient and produced in an ethical way; and

Whereas, the objective of the land use plan will be to ensure the needs of the community are met while protecting our natural resources and waterways in and around the community; and

Whereas, the land use plan will provide Chief and Council with a vision for future possibilities and will realize projects voiced during the comprehensive community planning consultation sessions; and

Whereas, the land use plan will further support the community vision outline in the comprehensive community plan by making clear linkages between activities occurring before and after the plan's development; and

Whereas, the community land use plan's expected outcomes may include: creating zoning, set asides for protection (cultural sites, burial grounds, harvesting areas, etc), map boundaries, identify land issues and resolve them, update lots, improve civic addressing, support community engagement, utilize traditional knowledge keepers and adapt to climate change; and

Therefore be it resolved that the Listuguj Mi'gmaq Government supports the development and elaboration of a community land use planning; and

Therefore be it resolved, the Listuguj Mi'gmaq Government mandates the Economic Development Unit to carry out the project objectives as outlined in the Land Use Planning Initiative Application.
