**WHEREAS:** the objective of the Mgnigng Elder's Circle (MEC) to bring together a team of Elder's, knowledge holders and Mi'gmaq Linguists whose purpose is to connect the claim process on matters related to the Mi'gmaq culture, traditions, laws, oral history, legends, and language.

**WHEREAS:** the Mgnigng Elder's Circle (MEC) will ensure that the Mi'gmaq knowledge on culture traditions and exercise of Mi'gmaq rights on Gespe'gewa'gi are central to the discussions and subsequent to the negotiations process.

**WHEREAS:** the Mgnigng Elder's Circle (MEC) will do the following:

1. advise, impart, and guide the development of the Mi'gmaq worldview perspectives in the negotiations process.
2. will provide directions, advice and recommendations to the Mi'gmawei Mawio'mi
3. will lead spiritual and cultural events related to the claims process, as requested:

**WHEREAS:** The MEC is asked to attend Mi'gmawei Mawio'mi meetings and Annual General Assembly (one a year).
