WHEREAS: The Listuguj Mi'gmaq Government has, by Order-in-Council, approved the creation of the Listuguj Mi'gmaq Development Centre (LMDCentre), responsible for Peoples' Development Planning and Program Design and Implementation.

WHEREAS: The LMDCentre operates under the direction of the Listuguj Mi'gmaq Development Council (LMDCouncil), as per Listuguj Mi'gmaq Government Order-in-Council.

WHEREAS: The LMDCenter, with the support of the Listuguj Mi'gmaq Government, prepared and submitted a proposal to establish a Regional Adult Education Center in Listuguj.

WHEREAS: The Listuguj Mi'gmaq Government has, by Order-in-Council, agreed to support the establishment and maintenance of a regional aboriginal adult education center within its territory.

WHEREAS: The LMDCouncil has given signing authority for financial transactions related to Adult Education operational funds in October 2016, to the Co-Managers of Elawsingewei Gina'muo'guom for the processing of their budget, as per the availability of approved funds by the FNAESC.

WHEREAS: The Listuguj Mi'gmaq Government recognizes that the LMDCentre is the administrator of funds for Elawsingewei Gina'muo'guom.

WHEREAS: With the transfer of Listuguj Adult Education employees from the FNAESC to the LMDCentre, in February 2019, the Listuguj Mi'gmaq Government recognizes the need for accountability and transparency to its People.
