**WHEREAS:** the Government of Quebec as represented by the Sous-Minister de la Securite Publique herein after referred to as (QUEBEC) and herein after referred to as AMENDMENT NUMBER 4 TO THE AGREEMENT ON THE PROVISION OF POLICING SERVICES IN THE COMMUNITY OF LISTUGUJ FROM APRIL 1ST 2018 TO MARCH 31ST 2019
