**WHEREAS:** The First Nations Finance Authority (FNFA} is created under the First Nations Fiscal Management Act (FMA} as a non-profit corporation without share capital;

**WHEREAS:** Listuguj Mi'gmaq Government is scheduled under the FMA;

**WHEREAS:** one of the purposes of the FMA is to secure for its Borrowing Members financing from the FNFA;

**WHEREAS:** Listuguj Mi'gmaq Government wishes to become a Borrowing Member of the FNFA;

**WHEREAS:** Listuguj Mi'gmaq Government has identified Chief Scott Martin as the contact person of Listuguj Mi'gmaq Government to provide information to the FNFA required for consideration of the application to become a Borrowing member of the FNFA

**THEREFORE BE IT RESOLVED THAT:**

The Listuguj Mi'gmaq Government hereby applies to become a Borrowing Member of the FNFA and will:

- a) provide the FNFA with a copy of the Financial Performance Certificate or Finance Management System Certificate issued to Listuguj Mi'gmaq Government by the First Nations Financial Management Board (FMB} under section 50(3) of the FMA and provide the FNFA with a copy of the confirmation from the FMB that their Financial Administration Law has been approved by the FMB;
- b) manage and operate its financial administration system in material compliance with the certificate issued by the FMB and the FMB standards applicable to the certificate issued;

- c) upon communication from the FNF A Board that the Listuguj Mi'gmaq Government has been accepted as a Borrowing Member, designate by resolution of Council either the Chief or Councillor as the Listuguj Mi'gmaq Government representative to the FNFA, and send a copy of this resolution to the FNFA;
- d) comply with the terms and conditions of being a Borrowing Member of the FNFA; and
- e) execute all such other documents as maybe required by the FNF A for Borrowing Members.
