WHEREAS: Economic and community development is a priority for the Listuguj Mi'gmaq Government;

WHEREAS: The Government of Quebec issued Order in Council # 866-2022 regarding the establishment of the Indigenous Initiative Fund IV (IIF IV) on May 25, 2022;

WHEREAS: The Listuguj Mi'gmaq Government wishes to enter into a special agreement with the Government of Quebec to set the terms and conditions governing the application of the IIF IV;

WHEREAS: The signing of the said special agreement is a prerequisite for the Listuguj Mi'gmaq Government's use of the funds (\$1,660,000) allocated to it as part of the economic development component of the IIF IV;

WHEREAS: The signing of the said special agreement is also a prerequisite for the Listuguj Mi'gmaq Government's ability to access additional funds equivalent to the balance of the preceding Indigenous Initiative Fund agreement. This balance, which stands at \$2,088,481, would bring the total budget for the economic development section to \$3,748,481;

WHEREAS: The agreement will provide up to \$1 million under the community infrastructure section, in addition to \$562,655, which is the amount that is still available for use in the context of the community infrastructure budget allowance under the Indigenous Initiative Fund III;

WHEREAS: To allow for greater flexibility in the use of funds, projects that comply with the criteria governing the economic development section are now eligible for funding under the community infrastructure section;

WHEREAS: Conversely, projects that comply with the criteria governing the community infrastructure section are eligible for funding under the economic development section, on the condition that Council has committed the entire budget available under the community infrastructure section;


