WHEREAS: the Listuguj Mi'gmaq Government (LMG) has already supported the principles of comprehensive community planning (CCP) and has deemed CCP as an essential long-term and short-term planning tool that promotes good governance and leadership in Listuguj (O.I.C. 2357).

WHEREAS: the LMG officially adopted the Listuguj Mi'gmaq Community Plan (LMCP) on March 20, 2018 and supported its on-going implementation and evaluation (O.I.C. 2357).

WHEREAS: the LMG recognizes the LMCP must remain current and relevant to community members, therefore, comprehensive community planning should be reviewed and updated every 5 to 7 years to support the practice of community participation in governance (O.I.C. 2357).

WHEREAS: the current LMCP began development in 2012 and was officially adopted in 2018 the LMG acknowledges that a review and update of the LMCP is necessary for 2023-2024.

WHEREAS: the LMG supports the current Comprehensive Community Planning Coordinator, Dawn Germain-Metallic, in efforts to update and revise the LMCP through community engagement and consultation with LMG and political leadership.

WHEREAS: The LMCP review and update process will move through three phases

- Phase 1: Communication and Engagement, Data Collection
- Phase 2: Data Analysis, Community Validation, Document Preparation
- Phase 3: New LMCP Approval & Adoption, Document Publishing & Distribution

WHEREAS: the LMCP update and review project will be financially supported by LMG Economic Development Unit (LEDU) core funding and/or Professional & Institutional Development (P&ID) funding. Own Source Revenue (OSR) funding will not be required for this project.
