WHEREAS: LNU and Pacific Drive needs storm sewage network to allow proper surface drainage and manage underground water coming from the residences sump pump and reconstruct the pavement.

WHEREAS: The Listuguj Mi'gmaq Government successfully obtained funding to perform the drainage and pave for the amount of 4,393,266 through Indigenous Service Canada as per Funding Letter GCdocs#115778763 Dated July 17, 2023

WHEREAS: the drinking water upgrade will be funded by ISC as per the project brief GCDOCS 102181420 dated April 20, 2022

WHEREAS: Listuguj Mi'gmaq Government and Capital & Infrastructure posted a call for tender on June 14, 2023

WHEREAS: The Tender Opening took place on July 6, 2023

WHEREAS: Two proposal were received at the closing time as follow:

Leon Chouinard - \$4,402,104.87
Action Progex INC- \$5,279,983.00

The project team and the department of Capital & Infrastructure recommend to award the contract to the lowest compliant bidder; Leon Chouinard
