**WHEREAS:** the Listuguj Mi'gmaq Government (the Council) has notified the Minister of Transport and Sustainable Mobility (the Minister) of its need to construct a level crossing and warning system and crossing surface across the Gaspé Peninsula Railway right-of-way at Mile 11.08 of the Cascapédia subdivision, a mileage point which is located on Lot 6 178 640, owned by the Minister;

**WHEREAS:** the Council and the Minister have negotiated in the last 3 years the terms and conditions of the level crossing agreement (the Agreement) namely in French the:

“Entente relative à la construction d’un passage à niveau et d’un système d’avertissement ainsi qu’à l’installation de canalisations traversant l’emprise du Chemin de fer de la Gaspésie au point milliaire 11.08 de la subdivision Cascapédia – No. 202457”

or in English the:

“Agreement for the construction of a level crossing and warning system and the installation of conduits across the Gaspé Peninsula Railway right-of-way at Mile 11.08 of the Cascapédia subdivision – No. 202457”

**WHEREAS:** the Council undertakes to respect the terms and conditions outlined in the Agreement, particularly that the preparation of the project, the construction, the work supervision and the maintenance works will be entirely paid by the Council.

**WHEREAS:** the Minister undertakes to respect the terms and conditions outlined in the Agreement.
