WHEREAS: The communities of Listuguj, Gesgapegiag and Gespeg have signed a Cultural Development Agreement with MCC, in which MCC may contribute up to 75% of eligible expenditures;

WHEREAS: MCC's budget allocation provides an additional \$76,000 to enhance the existing Aboriginal cultural development agreement with Mi'gmaq communities for the financial year 2023-2024, for actions concerning language revitalization;

WHEREAS: The MCC's budget allocation also provides an additional \$70,000 to extend the current agreement to add a 4th year (2024-2025);

WHEREAS: The agreement would now cover 4 years and that MCC's contribution would total \$375,000 for the agreement;

WHEREAS: A minimum contribution of 25% (in cash and/or services) must be provided by the beneficiaries and partners of the agreement;

WHEREAS: The Agreement Steering Committee has developed a preliminary action plan that evolves according to the priorities and needs of each community;

WHEREAS: The community of Gesgapegiag has agreed to act as mandatory of the agreement, on behalf of the 3 communities;

BE IT THEREFORE RESOLVED:

THAT: The Listuguj Mi'gmaq Government accepts the \$76,000 enhancement offer to support language revitalization actions the Cultural Development Agreement for the three Mi'gmaq communities of Gespe'gewa'gi;

THAT: The Listuguj Mi'gmaq Government accepts the additional \$70,000 to extend the current agreement for an additional year in 2024-2025;

THAT: The Listuguj Mi'gmaq Government authorizes the community of Gesgapegiag to submit the application for enhancement and extension, to sign all documents relating to this agreement and to manage the funds on behalf of the three communities, as agreed between them;

THAT; The Listuguj Mi'gmaq Government agrees to contribute (in services and/or money) to ensure the minimum contribution of 25% of the total costs of the agreement that must be provided by the beneficiaries of the agreement, according to the terms and conditions that will be determined between the 3 communities;
