**WHEREAS:** The Listuguj Mi'gmaq Government is intended to construct a new boulevard in Listuguj Hills to include all necessary infrastructure to support the future development north the railroad track.

**WHEREAS:** The Directorate of Capital and Infrastructure have successfully obtained funding from the department of Indigenous Service Canada for Riverside Extension Phase 2 and 3 for a total of \$8,067,908 as per letter dated November 9, 2023.

**WHEREAS:** The Listuguj Mi'gmaq Government and Directorate of Capital & Infrastructure had received 4 Tenders for the Project: Riverside Extension Phase 2 and 3.

**WHEREAS:** Following the Tender opening dated February 1st, 2024, at 10:00AM (Atlantic Time) LMG received four bids as follows:

Action Progex Inc.	\$ 7 460 916.00
Les Entreprises PEC Inc.	\$ 8 372 484.06
Construction L.F.G. Inc.	\$ 8 567 000.00
Les excavations Léon Chouinard et fils Ltée	\$ 9 029 880.85

**WHEREAS:** Taking into consideration the various criteria considered in the selection of the recommended bidder, such as the price submitted, the requirements of the specifications, the professional experience, and the compliance with the requirements of the tender document, the project consultant (W8banaki), recommends the awarding of the contract to Action Progex Inc.

**WHEREAS:** The Directorate of Capital and Infrastructure recommended awarding the contract to the lowest compliant bidder, Progex Inc. \$ 7,460,916.00.

**BE IT THEREFORE RESOLVED THAT:** Chief and Council approve the recommendations to award the contract to the lowest compliant bidder, Action Progex Inc. \$ 7,460,916.00 and authorize the Chief Executive Officer to award the contract.
