**WHEREAS:** The First Nations Child and Family Services (“FNCFS”) Program is providing funding under the Housing Projects Renovation & Construction Stream with the objective of tackling the housing needs of Indigenous children and families

**WHEREAS:** The construction of housing units has been identified as a priority by Listuguj Mi'gmaq Government (“LMG”) for the well-being of all community members

**WHEREAS:** The funding can be used for the creation of new single-family housing units since it meets the program’s criteria, mainly ‘addressing the housing needs and overall well-being of First Nations children and families’

**WHEREAS:** Indigenous Services Canada (“ISC”) confirmed funding for a total of \$694,580.00 to assist with housing construction and/or renovation projects that can be used for 2023-2024 expenditures,

**WHEREAS:** This initiative is specific to those identified as priority for those clients that are included with FNFCs and services therein;

**WHEREAS:** The Listuguj Community Social Services Department (“LCSSD”) will screen potential applicants as high priority and make recommendations;

**WHEREAS:** The LCSSD supports the decision of using the funds for the construction of three housing units,
